

Canadian Digital Adoption Program









- The Canadian government recognizes that how Canadians do business has changed. To stay
 competitive and grow, small and medium-sized businesses need to adopt new digital tools.
 They released the CDAP program in the 2021 budget to help.
- The grant covers up to 90% of the \$15,000 cost of retaining the services of a digital advisor to develop a digital adoption plan.
- Businesses also have the opportunity to then secure a 0% interest loan from the Business
 Development Bank of Canada (BDC) to facilitate the acquisition of new technology. In addition, applicants can leverage the help of talented post-secondary students and recent graduates through subsidized work placements.





To Qualify



- Sole proprietor or incorporated under the laws of Canada or a province/ territory
- For profit
- Privately owned
- Full time equivalent employees between 1 and 499
- \$500,000 to \$100M of annual revenues in one of the previous three years



About the Plan



1	Executive summary	A high-level summary of the key elements of the plan.
2	Current state analysis	An overview of key business information, external issues, and key IT information.
3	Digital adoption analysis and recommendations	Identify a minimum of three potential digital/ technology solutions and their benefits.
4	Implementation roadmap	Outline the key elements required to implement the recommended options including timeline, dependencies, and costs to acquire the technology.





About the Loan



- 100% online application
- 0% interest loan
- No guarantees (no personal guarantee or security agreement), No fees
- Amortization period: 6 years (5 years plus an initial postponement of 12 months)
- It usually takes around 14 days to process the loan.
- Businesses request the loan amount based on their revenue.
- Revenue \$500K to \$5M: loan between \$25K and \$50K
- Revenue \$5M or more: loan between \$25K and \$100K
- You have 6 months to apply for the loan through the unique link provided to you.




